



Welcome to NYU School of Law’s Self-Guided Tour. Hours for the Welcome Desk, located in Furman Hall, 245 Sullivan Street, are Monday through Friday 9a.m. – 5p.m., except Wednesday, 10a.m. – 5p.m. The Office of J.D. Applications to enroll in Fall 2008 are available in early September 2007.

Fall 2007 classes end on December 7; spring semester classes will be held from January 14 to April 29, except March 17 – 21. Classes meet in Vanderbilt Hall, 40 Washington Square South, and in the Law School’s newest building, Furman Hall, 245 Sullivan Street. Most faculty offices are in Vanderbilt Hall.

Other locations of interest:

The Mercer Street Residence (240 Mercer Street, between West Third and Bleecker Streets) – An apartment-style Law School residence, housing mostly upper-level and married students, and some faculty members. Student organizations are located here, but they are not usually staffed. The Law School’s Office of Residence Services is located in the lobby of this building.

D’Agostino Hall (110 West Third Street) – An apartment-style Law School residence, as well as the home to many of the Law School’s various journal offices, programs, centers and institutes. A law student lounge featuring computers with Internet access is located on the Commons level and various administrative offices are located on the Mezzanine level.

**\*\*\*Note:** Access to the Mercer Street Residence and D’Agostino Hall is restricted. Should you have any questions regarding Law School housing, please feel free to visit the Office of Residence Life located in the lobby of The Mercer Street Residence (240 Mercer Street).

NYU Professional Bookstore (530 LaGuardia Place, between West Third and Bleecker Streets) – Where law, business, social work, and public service students purchase texts, stationery, and general interest items.

NYU Office for International Students and Scholars (OISS) (561 LaGuardia Place, corner of West Third Street) – This office provides comprehensive support and advisory services for New York University’s international students, scholars, and their dependents.

**VANDERBILT HALL (40 Washington Square South)**  
Entrance on West Fourth Street/Washington Square South

**First Floor**

*Room 110* – A newly-renovated student lounge that houses student lockers and mailboxes.

*Law Library* – One of the most extensive collections in the country, including online computer research systems. Personal computers are located here. Use the pass on page 1 to gain entry and temporary access to the new Law Library.

*Tishman Auditorium* – The site for Law School events such as the Law Revue show and conferences.

*Greenberg Lounge* – Used for Law School events and receptions.

**Second Floor**

*Bulletin Boards* – Student organizations and administrative offices post information for the Law School community about events, meetings, and academic matters.

*Golding Lounge* - Law student lounge. Coffee, bagels, sandwiches, beverages, etc. are sold on weekdays during the academic year. This lounge also has a terrace overlooking West Third street and D'Agostino Hall.

*Classrooms* – First year and upper-level classes are held in these rooms. Room 208 is a smaller, seminar-style classroom. Please be sure that no class is in session before walking into a room. All classrooms in this building are fully wired for internet use (“smart”).

**Third and Fourth Floors**

Faculty and administrative offices are located on these floors.

**FURMAN HALL (245 Sullivan Street)**  
Entrance on Sullivan Street

**First Floor**

*Wilf Lobby* – Directly inside the main entrance. A staircase to the Second and Third Floors is at the far right of the Lobby. The hallway to the near right of the Information Desk leads to the elevators and to:

*Room 110* – An example of a small, seminar-style classroom. There are more seminar-style classrooms on the First, Second and Third Floors. Please be sure that no class is in session before entering a room. All classrooms in the building are fully wired for internet use (“smart”).



*Guarini Study Lounge* – A quiet student study lounge. Part of the site was once the home of Edgar Allan Poe; this room is designed and decorated to reflect historical accuracy to when Poe lived here.

*Wachtell, Lipton, Rosen & Katz Café* – Law Students lounge. Coffee, bagels, sandwiches, beverages, etc. are sold on weekdays during the academic year.

## **Second Floor**

*Sexton Student Forum* – Informal student meeting place/lounge. The Sexton Student Forum extends to a balcony on the Third Floor.

There are three medium-sized classrooms and one large lecture classroom on this floor. Please be sure that no class is in session before entering a room. All classrooms in the building are “smart.”

## **Third Floor**

*Sexton Student Forum Balcony* – Overlooks the Sexton Student Forum on the Second Floor.

*Group Study Rooms* – For use by student study groups. Room 312 is an example. Please be sure a room is not in use before entering.

*Flex Seminar/Court Rooms* – Flexible seminar classrooms that can be reconfigured for Lawyering, Clinical, or Moot Court exercises; Room 328 is an example. Please be sure that no class is in session before entering a room.

There are several small and medium-sized classrooms on this floor, as well as some administrative offices, including the Hauser Global Law School Program. Please be sure that no class is in session before entering a room. All classrooms in the building are “smart.”

## **Fourth Floor**

Several administrative offices, including Academic & Student Services, Records & Registration, Student Financial Services, Career Services, and the Public Interest Law Center are located on this floor.

## **Fifth and Sixth Floors**

The Jacob Fuchsberg Clinical Law Center is located on these floors. Access to these floors is restricted.

## **Seventh and Eighth Floors**

Residential floors. Access to these floors is restricted.

**Ninth Floor**

Meeting rooms for faculty colloquia are located on this floor. Access to this floor is restricted.

**Cellar Levels**

Administrative offices for the Lawyering Program and additional Law Library space are located on these floors. Access to these floors is restricted.
