"ROOM CAP." is the physical capacity of the room based on the number of seats in the room. "ENRL. LIMIT" is the limit placed on the size of the class by the faculty. When considering enrollment information, please keep in mind that enrollment may vary from year to year in the same courses, depending on instructor, time of day and the day the course meets, and the number of course sections offered.
