## VANDERBILT HALL (40 Washington Square South)

\*Enter through courtyard on West Fourth Street/Washington Square South.

#### **First Floor**

- <u>Seryl and Charles Kushner Student Lounge</u>—A student lounge that houses student lockers and mailboxes.
- <u>Law Library</u>—One of the most extensive collections in the country, including online computer research systems. Use your nametag to gain entry and temporary access to the Law Library.
- <u>Tishman Auditorium</u>—The auditorium can accommodate up to 450 people for special events, conferences, and the annual *Law Revue* show.
- <u>Greenberg Lounge</u>—Used for law school events and receptions; the walls are adorned with the portraits of the school's past Deans.

#### **Second Floor**

- <u>Golding Lounge</u>—Law student lounge. Coffee, bagels, sandwiches, beverages, etc. are sold on weekdays during the academic year. This lounge also has a terrace overlooking West Third Street and D'Agostino Hall.
- <u>Classrooms</u>—First-year and upper-level classes are held in these rooms. Room 208 is a smaller, seminar-style classroom. All classrooms in this building are fully wired for internet use.
- <u>Bulletin Boards</u>—Student organizations and administrative offices post information for the law school community about events, meetings, and academic matters.

#### **Third and Fourth Floors**

• Faculty and administrative offices are located on these floors.

## **RESIDENCE HALLS**

## D'Agostino Hall(W. 3rd Street)/Mercer Hall(240 Mercer Street)

- Apartment style residence halls for both students and faculty. Also home to the law school's journal offices, student organizations, moot court board, and student bar association.
- Although individual rooms are not available for visits, the law school's <u>Office of Residence Services</u> is located in the lobby of Mercer Hall and is open to visitors.

## FURMAN HALL (245 Sullivan Street)

#### **First Floor**

- <u>Wilf Lobby</u>—Directly inside the main entrance. A staircase to the Second and Third Floors is at the far right of the Lobby. The hallway to the near right of the Welcome Desk leads to the elevators.
- <u>Room 110</u>—An example of a small, seminar-style classroom. Seminarstyle classrooms can also be found on the Second and Third Floors. All classrooms in the building are fully wired for internet use.
- <u>Frank J. Guarini, Sr. and Caroline L. Guarini Study Lounge</u>—A quiet student study lounge. Part of the site was once the home of Edgar Allan Poe during the time he published his famous poem "The Raven."
- <u>Wachtell, Lipton, Rosen & Katz Student Café</u>—Law student lounge. Coffee, sandwiches, and beverages are sold on weekdays during the academic year.

#### **Second Floor**

- <u>The John Sexton Student Forum</u>—Informal student meeting place/ lounge. Computer terminals with internet and printing access are available for students.
- There are three medium-sized classrooms and one large lecture classroom on this floor.

#### **Third Floor**

- <u>The John Sexton Student Forum Balcony</u>—Overlooks the Sexton Student Forum on the Second Floor.
- <u>Group Study Rooms</u>—Available for use by student study groups. Room 312 is an example.
- <u>Flex Seminar/Court Rooms</u>—Flexible seminar classrooms that can be reconfigured for Lawyering, Clinical, or Moot Court exercises; Room 328 is an example.
- There are several small and medium-sized classrooms on this floor, as well as administrative offices, including the Hauser Global Law School Program.

#### **Fourth Floor**

<u>Administrative Offices</u>—Academic & Student Services (Room 474), Career Services (Room 440), Records & Registration, Student Affairs (Room 474), Student Financial Services (Suite 400), and the Public Interest Law Center (Room 430).

### Fifth and Sixth Floors

• The Jacob Fuchsberg Clinical Law Center is located on the fifth and sixth floors.
