

Singapore Summer & Winter Terms 2012

(Schedule subject to updates)

Unless otherwise indicated, classes are taught at 1 credit per week and meet 175 minutes four days a week (Monday-Thursday).

Classes taught at 2 credits in 3 weeks meet for 117 minutes four days a week.

Fridays are designated reading days, but may be used for classes if needed.

Students are permitted to take only one course in any Block during the intensive Summer and Winter Terms. Students are permitted TWO exceptions to this. In other words, across the Summer and Winter Terms, a student may take two courses in a block on two occasions.

Students should aim to complete at least 10 credits during the Summer Term and 2 credits during the NYU Winter Term.

Credit Requirements to complete NYU LL.M. in Global Business Law:

1. NYU@NUS students must take 20 of the 24 credits with NYU faculty, including 12 with full-time NYU faculty (not global or adjunct faculty), who are indicated in the schedule as "(FT)".
2. Students wishing to qualify for the New York Bar Exam based on their study in Singapore must also complete at least four courses, totaling at least 10 credits, designated as "basic American law courses," one of which must be Legal & Ethical Rules Governing American Lawyers. These are indicated in the schedule as "(BALC)".
3. At the end of the program, students who do not have the right to sit for the NY Bar exam with their undergraduate studies, must complete the 100-hour 12-week New York Seminar. This begins in May and concludes in advance of the July sitting of the NY Bar exam.
