- 2. Discussion and Creation of Ad Hoc Committees** **President**
  - a. By creating ad hoc committees, we are hoping to provide room for representatives on the SBA to address recurring issues and to act as a reporting mechanisms to the SBA.
  - b. *Students may have concerns about the Student Organizations Committee being too much of a "Big Brother."* Committee will not exercise direct control, but will act in an advisory capacity, especially to new groups seeking SBA recognition.
  - c. Motion by President to accept recommendation to initiate all committees with President as an ex officio member. Seconded by Chris Hughes. Approved unanimously.
  - d. Motion by President to adopt ad hoc designations, with amendments. Seconded by Chris Porcelli. Approved unanimously.
- 3. Externship Committee Nominee** **President**
  - a. SBA members are always able to forward recommendations for open positions.
  - b. *Do we know what the role of the committee will be?* This committee was formed by the Dean to address concerns about the lack of externship credits and opportunities.
  - c. Motion to solicit applications for position by Jordan Chisolm. Seconded by Chloe Hurley. Approved unanimously.
- 4. Election Committee Update** **VP & 3L Reps**
  - a. 2 LLM representatives running. Will be short 1 LLM Representative and 1 Transfer Representative. We have the power to fill these positions with appointments. Had to solicit people from some 1L sections and left it open for one day.
  - b. Website is up and everyone will be ready to vote tomorrow. 8AM Wednesday through 8PM Thursday. Results will be announced the next morning.
- 5. Other Board Updates** **All**
  - a. Social Chairs have been looped into conversation between editors of various journal editors and they were told that they cannot pre-game in the journal offices. Will it be possible to find other spaces? Will keep lines of communication open and follow up.
  - b. We should bring students up-to-date about requirements and limitations that get lost in the Docket (eg. adjunct cap) or work to get rid of the adjunct cap.
  - c. The Dean started an adjunct cap task force to discuss this issue that is a faculty-only committee that will be meeting in the Spring.
  - d. *What happened to tethering staplers to the printer?* They are buying new printers and are going to put staplers with all of them.
  - e. We should have something in the Spring semester about choosing classes for 2L year.
  - f. *Is it possible to ask Academic Affairs to make ABRA flag you for going over the adjunct cap?*
  - g. Student Senate: Working on printing in Grad lounge in Bobst; "It's on Us" Campaign – trying to expand campaign to include domestic violence; Planning NYU-wide grad event with TED-style talks on maneuvering their career field – hoping to host at the Law School. "Abolish the Box" campaign; Taking the box out of the Common Application that you have been convicted of a felony.
