## 1. INTRODUCTION

The International Finance and Development (IFD) fellowships are designed to provide fellows with the opportunity to gain experience working with international organizations engaged in the areas of finance, development, intellectual property and international dispute resolution. The fellowships are for a minimum of 10 or 12 weeks (depending on the organization) in duration for which the Law School provides modest financial support.

Current LL.M. students at NYU School of Law, including NYU@NUS, are eligible to apply. This year we expect to select thirteen students as IFD Fellows. We are currently accepting applications for fellowships at:

L.LM. students with degrees from Eastern Europe and/or experience with M&A and other corporate and financing transactions are particularly encouraged to apply. The intern's duties will be varied and may include: attending meetings, reviewing and preparing legal document (e.g., powers of attorney, agreements, and mandate letters), organizing documents, helping with closings, preparing training sessions, filing, improving systems, and assisting in organizing conferences.

**Fellow Qualifications:** The IFC seeks interns with a corporate background. Prior knowledge of corporate transactions, cross-border deals, equity, and project finance will be an added advantage. The IFC also seeks interns that are able to work in teams and have strong communication skills. Good work ethic and a sincere interest in public service and IFC's mission are also important. Knowledge of Spanish and/or Portuguese will be preferred.

## International Monetary Fund (IMF)

**Description:** The IMF is an excellent placement for those with a public service orientation and background and interest in policy and regulation. ## Duration: 12 weeks

**Description:** The OECD's mission – Better Policies for Better Lives – promotes policies that will improve the economic and social well-being of people around the world. It provides a unique forum in which governments work together to share experiences on what drives economic, social and environmental change, seeking solutions to common problems. The Directorate for Legal Affairs (LEG) is a small and highly integrated team which provides advice and information on the legal, institutional and procedural aspects of the Organization's activities. The Directorate also serves as coordinator of the discussions with candidate countries for OECD membership, which involves the analysis of the candidate's position on some 250 OECD legal instruments.

The principal function of the selected candidate will be to assist the Legal Advisers working in relation to matters relating to public international law, legal instruments of the Organization, the coordination of membership discussions with accession candidates, the Organization's relations with non-Members as well as procedural and governance issues.

**Fellow Qualifications:** The OECD seeks a candidate with strong knowledge of public international law, and with excellent research and drafting skills. Prior experience in an international organization or law firm would be an asset. Fluency in English is essential and a working knowledge of French is an advantage.

World Intellectual Property Organization (WIPO)

**Description:** WIPO is the United Nations agency dedicated to the use of intellectual property (patents, copyright, trademarks, designs, etc.). Its mission is to promote innovation and creativity for the economic, social and cultural development of all countries, through a balanced and effective international intellectual property system. The IFD Fellow will be placed in the Office of the Legal Counsel (OLC). Duties for WIPO's intern will include: legal research and writing of opinions and memoranda; contract drafting; participating in discussions and assisting in tasks concerning the application, interpretation and modification of the basic constituent instrument of the Organization as well as other international treaties and agreements administered by the Organization; participating in discussions and assisting on questions concerning the legal status of the Organization, its privileges and immunities and on those of its staff; assisting in the application and resolution of legal questions relating to the preparation and application of the WIPO Staff Regulations and Staff Rules; and any other tasks assigned by the Legal Counsel. Fellow Qualifications: Prior knowledge of public international law or international civil service law will be an advantage.

## 3. NOMINATIONS TO WORLD BANK LIP & LAP PROGRAMS

Applicants to the IFD Fellowships can also elect to be considered for nominations by NYU Law School for the LIP/LAP Programs run by the World Bank. NYU School of Law puts forward one nomination for the LIP program, and two nominations for the LAP Program, each year. NYU School of Law does not guarantee the success of the nominations, nor award any financial support to successful applicants.

## Legal Interns Program (LIP)

LIP is open to individuals with a Master degree in law, LLM or equivalent, or current Master degree in law/LLM students

who are nationals of the Bank's member countries, and attracts a large number of highly qualified candidates. The goal of this program is to offer to successful candidates an opportunity to gain legal experience, improve their skills as well as the experience of working in an international environment. Interns generally find the experience to be rewarding and interesting. The World Bank pays an hourly salary to all Interns and, where applicable, provides an allowance towards travel expenses. Interns are responsible for their own living accommodations and health insurance. The positions are located in Washington, DC and can last from six to twelve months depending on the start date. Nominees are then selected on a needs basis, with urgent fillings.

### Legal Associates Program (LAP)

LAP is designed to introduce talented young legal professionals from around the world to the World Bank. Legal Associates who participate in the program will initially be given a one year term appointment with the Legal Vice Presidency, with the possibility of an additional one year term, depending on their individual performance and the business needs of the Legal Vice Presidency.

The purpose of the Legal Associate Program is not to lead to further employment with the World Bank but to provide highly qualified young legal professionals an opportunity to acquire direct practical experience in the Legal Vice Presidency's work under the direct supervisions of experienced World Bank staff. However, a number of Legal Associates, having met the necessary requirements, have gone onto further assignments with the Legal Vice Presidency or elsewhere in the World Bank Group.

Eligibility for Application:

- Degree in law: All applicants must have obtained a degree in law (LLB, LLM, PHD or equivalent). It is not required to have a degree from a US university nor is it considered an advantage or a disadvantage.
- Nationality: Applicants must be citizens of a member country of the World Bank to be eligible and satisfy all other hiring conditions related to employment at the World Bank.
- Languages: Fluency in English (oral and written) is essential. A good command of French and/or Spanish would be highly desirable. Fluency in Arabic, Chinese, Russian, or Portuguese would be a strong advantage in the recruitment process.
- Prior Experience: A minimum of one year and no more than two years of work experience is required post degree in law.

Applicants will be placed in the Institutional Administration Practice Group (LEGIA), the Environmental and International Law Practice Group (LEGEN) or a regional group. ## 4. TERMS AND CONDITIONS

#### Terms

- All fellowships are subject to approval by each fellowship placement organization. No fellowship will be granted until the applicant is approved by the relevant organization.
- Applicants who are awarded an IFD Fellowship are required to accept the fellowship.
- Chosen fellows are responsible in obtaining their own work visas, permits, medical insurance, and any other possible requirement in order to pursue the fellowship placement.

#### Requirements

Selected fellows will receive the full fellowship award provided by the Law School contingent upon the fulfillment of all obligations listed below:

- Duration: The fellowships are for a minimum of 10 or 12 weeks depending on the organization. The internship will take place in summer or fall following graduation from the LL.M. program in 2014. IFD Fellows must stay with the organization for the 10 or 12 week period. Please note that an organization may negotiate with the selected IFD Fellow a longer period of placement the terms of such extension are subject to agreement between the student and the organization; no additional funding will be provided from NYU.
- **Report:** IFD Fellows must submit a report to the Office of Graduate Affairs that provides details about the IFD Fellow's experience at the respective organization (a standard form will be provided.) The deadline to submit the report is within the last week of the fellowship placement.
- **Paper:** IFD Fellows must complete a supervised research paper, case study or practical memo on an international law issue discussed in advance with an academic supervisor at NYU School of Law. The deadline to submit the paper is January 5, 2015 (regardless of when the fellowship placements start). The paper must be submitted to the faculty supervisor and the Office of Graduate Affairs. Please note that the paper cannot be used for course credit.
- **Community/Communication:** After completion of the fellowship placement and upon request, IFD Fellows must be available (in person, via email or by phone) to answer questions from NYU Law students and IFD applicants, especially during the application process.

#### 5. FINANCIAL AWARD

IFD Fellows will receive \$6,500 USD in support of the fellowship. The financial support is awarded on a need-blind basis. An initial stipend of \$3,000 will be distributed prior to the beginning of the fellowship placement. An additional award of \$3,500 will be disbursed after the IFD Fellow has a) successfully completed the fellowship placement; b) submitted the required report to the Office of Graduate Affairs; and c) submitted the research paper, case study or practical memo to the Office of Graduate Affairs. IFD Fellows who do not meet in a timely fashion all the requirements set forth above will not receive the additional \$3,500 award and will lose the designation of Fellows.

*Please note*: Expenses related to some placements, including airfare, housing, insurance, and inoculations, are likely to exceed the amount provided by the stipend. In addition, selected IFD Fellows who are not U.S. citizens or permanent residents may have their stipend amount reduced due to tax obligations (depending on the tax treaty of the fellow's country with the United States).

In addition, New York applicants must submit four (4) paper copies of the application package to the Office of Graduate Affairs, Furman Hall 340 (this does not apply to NYU@NUS students).

The application package must include (in the order below):

- A. **Completed cover sheet** (first page of this application). Please indicate fellowship placement(s) for which you are applying.
- B. **Completed Organization Cover Sheet**. Please submit only one, even if applying to several organizations. Leave organization name and notes blank.
- C. Résumé
- D. **Home School Transcript**. Please include copies of your law school transcript from your home institution (unofficial copies are acceptable).
- E. **NYU Transcript**. Please include an unofficial copy from Albert (note that you will not have grades yet, but the transcript will show the courses you are taking).
- F. **Statement(s) of Interest**. Please include in your application a short statement of interest (no longer than 500 words) explaining why you want to undertake a specific fellowship. You may include any relevant academic, professional or other experience, skills particularly relevant to the organization, and what you hope to gain by undertaking the fellowship. If you are applying for more than one fellowship placement, please include a separate statement for each placement (you may rank your order of preference.)

*Note*: UNIDRIOT applicants should indicate their interest for a particular current project at UNIDRIOT. IFC applicants do not have to submit separate statements of interest for each location.

G. Writing Sample for the World Bank. Students applying to the World Bank must include a writing sample (no limit on length).

*Please note*: To the extent a placement organization requires the submission of its own application, selected IFD Fellows shall complete and provide such application in an expeditious fashion.

## 7. INTERVIEWS AND SELECTION

## **IFD Fellowships**

After reviewing the applications, a pool of applicants will be selected for interviews to be conducted in New York on November 18, 19 and 20. NYU@NUS students will be interviewed in Singapore during the month of November. Once the interviews conclude, a number of applications will be forwarded to each placement organization which will select its IFD Fellow. All candidates will be alerted of the outcomes at all stages. Applicants selected for an IFD Fellowship will be featured on the NYU Law's website as Fellows.

## LIP/LAP

All of the IFD Applicants that are selected for interview and that have indicated they also wish to apply for nomination for LIP/LAP will be considered. Once the interviews conclude in November, NYU School of Law will forward nominations to the World Bank, which will then select their Interns/Associates.
