4. Nominees must have demonstrated commitment to the public interest/public service.
5. Nominees must intend to pursue careers in public interest law.

3.  A list of 2-3 references of people with first hand knowledge of the nominee and the nominee's work (*i.e.*, law school professors or employers).
4.  Optional supporting material (*i.e.*, the nominee's current résumé or curriculum vitae, and letters of recommendation from the nominee's law school professors or employers.)
