### **Law Alumni Association**

The Board of Directors of the New York University Law Alumni Association (LAA) is dedicated to connecting alumni to the Law School by providing educational and social programming and volunteer opportunities. Throughout the year, the Board partners with the Offices of Admissions, Student Services, and Career Services to assist with recruitment, orientation, and mentoring. The Association also organizes and sponsors lectures, symposia and other events for alumni, including an annual Fall Lecture, the Annual Alumni Luncheon, the LAA Awards Luncheon during Reunion, and networking events for recent graduates.

### **Membership Criteria**

Qualities considered important for election to the LAA Board include:

- Interest in furthering the LAA's mission of connecting alumni to the Law School.
- Active engagement in activities of the Law School as a student or alumnus/a.
- Strong, proven leadership and service to the Law School or the legal profession.
- Ability to work well individually and as part of a team.

### **Responsibilities of Membership**

LAA Board members are expected to fulfill the following responsibilities to the best of their ability:

- Attend all meetings of the Board, either in person or telephonically. The Board meets five times per year; meetings are held on campus in the evenings and typically last 60-90 minutes.
- Attend the Annual Alumni Luncheon, the Annual Fall Lecture, and other events sponsored by the Association.
- Participate actively on at least two LAA committees.
- Contribute annually to the Law School at a level based on the member's personal financial situation.

### **Term of Office**

Directors are elected to a four-year term. Directors may be eligible for re-election following a one-year hiatus at the close of their term.

Nominations must be submitted by **August 11, 2014**. Nominations received after this date will be considered for membership the following year.
