### Bobby Geren, 2L Representative Candidate



- Affordability: The experience of attending law school can be stressful, especially when personal finances and loans are factored into the equation. If I am lucky enough to serve as one of your 2L Class Representatives, I will work with other members of the SBA to address affordability issues that are so important to every member of our class. I will aim to expand the Affordability Committee to make financial aid more accessible to all students, and will petition the administration to make its Loan Repayment Assistance Program more transparent.
- O Pro Bono Opportunities: As law students, we don't claim to know everything about the law. Despite this, we are in a unique position to help people in need of legal services through participating in pro bono matters. Pro bono work is not only a requirement to be admitted to the bar in many states (including New York), but it is also a way to build our advocacy skills while providing essential legal services to the underprivileged. If elected, I will work to increase the availability of pro bono work for all students and implement a system in which existing opportunities are given greater visibility.
- Class of 2019 Events: We are undoubtedly the best class at NYU Law. For this reason, I think we should put more effort into organizing events to celebrate ourselves. With SBA subsidization, I hope to plan several class events next year designed to increase our sense of community and foster new relationships.
