To apply for the Grunin Prize or to nominate another party's project, you must complete the Grunin Prize submission form located at https://www.law.nyu.edu/centers/grunin-social-entrepreneurship/grunin-prize. To guide your preparation, we invite you to use this PDF of the submission form.

Please note that:

- The Grunin Prize aims to recognize a *specific project or solution* developed by a lawyer or legal team to advance the fields of social entrepreneurship and impact investing.
- While information on a project or solution is crucial to the application, the primary focus should be on the work and contributions of the lawyers involved.
- Applicants and nominators can submit more than one project for consideration. A separate submission form must be completed for each project.
- Applicants and nominators are welcome to resubmit a previously nominated project that meets the eligibility criteria and has not received the Grunin Prize.
- If nominating another party's project, nominators must coordinate with nominees to ensure all required information is provided in the submission form.
- Supplemental materials will not be accepted. However, as needed, applicants and nominees may be asked to provide additional information for consideration by the judging panel.
- Once notified, finalists will be expected to (i) participate in an interview with the judging panel and (ii) liaise with the Grunin Center to coordinate a communications plan and develop a Grunin Prize video
