This number is weighted so that bar pass rates from jurisdictions where more of the Law School's graduates sat for the bar exam have a greater impact on the ABA weighted average bar pass rate than bar pass rates from jurisdictions where fewer of the Law School's graduates sat for the bar exam.

<sup>\*\*\*\*</sup>The difference between the Law School pass rate and the ABA weighted average bar pass rate compares the performance of the Law School's graduates on the bar exam in all jurisdictions where they took the bar exam for the first time with the performance of graduates from all ABA-accredited law schools on the bar exam in those same jurisdictions.
