WHAT ARE PROJECT FELLOWSHIPS?

Time-limited position

With a partner (host) organization

Executing a specific public interest legal project

Funded by an external project fellowship funder

WHO SHOULD CONSIDER PROJECT FELLOWSHIPS?

You have a passion for particular legal issue and/or population.

You have an idea for legal project to address unmet legal need.

You have career goals with limited entry-level options.

You plan to pursue public interest law

WHO SHOULD APPLY FOR PROJECT FELLOWSHIPS?


Genuinely passionate about the project

Host org supports both you and the project

Flexible and can tolerate uncertainty

Can navigate multiple job searches at once

PROJECT FELLOWSHIP VS GENERAL JOB SEARCH PROCESS

PROJECT FELLOWSHIPS

- Take a narrow approach
- Need to be sincerely excited and passionate
- Bigger lift & longer timelines

GENERAL JOB SEARCH

- Take a broad approach
- Focus on developing skills & experience that serve your long-term goals
- Look for positions that will help you achieve those skills/experience

2L SUMMER

Network with current/recent fellows

Look for & apply to sponsorship postings

Reach out to potential partner organizations

Narrow down project areas and ideas

Secure organizational partner.

Start drafting Skadden & EJW proposals.

APPLICATION TIMELINES

2L FALL

Finalize & submit Skadden & EJW applications!

Confirm other fellowships for which your org will sponsor you.

Interviews! Mock interviews with both your host & PILC.

Stay in touch with fellows and other networking contacts throughout!

HOW PILC CAN HELP

Talk through interests, priorities and options

Insight and guidance on the fellowship process

Help identify prospective partner organizations and contacts

Feedback on resumes, cover letters and proposals

HOW TO IDENTIFY POTENTIAL HOST ORGANIZATIONS

Research & consider organizations.

...where you have worked before.

...that are recruiting fellowship applicants.

...that have successfully hosted fellows.

...referred by your networking contacts.

...that
fit your
interests &
needs.

NOTE: Be aware of any funder requirements regarding host organizations. For example, Skadden requires at least two full-time attorneys on staff.

HOW TO REACH OUT TO POTENTIAL HOST ORGANIZATIONS



Personal Contacts

- Initial informal call or email
- Ask for time to talk or referral to best contact



Referred Contacts

- "Mini cover letter" email
- Ask for time to talk and/or information about fellowship sponsorship selection.
- Attach your resume!



Other Organizations

- Research org's website for best contact.
- Sleuth out contact's email. Avoid generic "info@" email.
- Send similar email to referred contacts.



Formal Postings

- Easy apply as directed!
- Check organization's career site first for official posting or general application directions

HOW TO REACH OUT TO POTENTIAL HOST ORGANIZATIONS

Are they looking to sponsor a project fellowship?

Do they have a process for selecting applicants to sponsor?

What is their timeline for making sponsorship decisions?

BEFORE COMMITTING TO A HOST ORGANIZATION

Speak With Current and Recent Fellows

- What was their experience like?
- Did they have adequate supervision?
- Were they able to focus primarily on their project?

Ask Important Questions

- Will you be their only fellowship candidate?
- Which fellowships will they sponsor you for?
- Can they supplement salary and provide benefits?
- What are the options post-fellowship?

Continued Job Search

- This is not a job offer!
- Can they commit to hiring you if you do not secure a fellowship?
- If not, be upfront about plans to apply to other positions as they arise.

GENERATING PROJECT IDEAS

What Do You Care About?

Think about **problems** rather than projects.

What issues get you the most fired up?

What is your dream job?

Reflect On Your Prior Work

Did you see unmet needs due to capacity or lack of services?

Did clients have particular recurring and unaddressed legal problems?

Were specific populations uniquely impacted by particular issue?


Research and Network

Read summaries of current and former projects.

Read news stories, journal articles, etc.

Reach out to practitioners, former supervisors and clinical professors
